Beautiful river land turned into wasteland and eventually compromising the river. Would like to see more protection of the land, more control of what development is allowed. Would like more information about the hours of operation, days of operation, and noise levels. Questioned how these will be monitored. Is the monitoring set up by Woodlands County? He noted that noise can be tolerated, to a degree, if the hours of operation are shorter. Traffic is also a concern; he anticipates that the route for gravel extraction would be along two sides of his property.

Mayor Rennie asked if there were any other comments or concerns with respect to this application. and closed the public hearing.

Cliff Utas noted that he has no objections to this gravel application
